Learning outcomes:			
The aim is to pass knowledge about the development of the state and law after February 1948, i.e. during the People's Democracy regime and Socialism. The students will acquire deeper knowledge about the People's Democratic and Socialist eras, which were very dynamic and controversial eras of national history. Especially the young researchers, therefore, study them eagerly. After taking the lessons, the students will be able to creatively and independently write a scientific study or a conference contribution on a respective topic.			
Schedule of subject:			
Constitutional Development after 1948: the Ninth-of-May Constitution, Relations between the Czechs and Slovaks and the Concepts of State in the 1960s (the Act on Federalisation). The Concept of Socialist Law, the so-called Two-Year Legal Plan, New Civil and Criminal Substantial and Procedural Codes, and the Code of Family Law. Changes in the Property Rights to Lands, Cooperative law, the New Concept of Labour Law, and Social Security Law. Economic Law and Destruction of Commercial Law. Development of Labour Law and Social Security Law, and the Support of a Socially Egalitarian Society. Legal Abuse in Practice (Crimes Against Humanity, Crimes Against Human and Civil Rights, Criminalisation of Political Opposition through de Lege Lata Tools). Soviet States in International Law and Fight for Human Rights. Relation of State and Churches, their Criminalisation, Control, and Repression. The Development of the Czechoslovak Jurisprudence – Legal Doctrines and Concepts v. Legal and Political Reality. Changes in Public Prosecution – Attorney General's Office, Advocacy, Notary.
