Upon successful completion of this course, students will gain an overview of the current development of doctrines and principles, as well as contemporary issues and dilemmas in commercial law and its key institutes. They will acquire a comparative perspective on how these issues are addressed across various legal systems. Students will be prepared to apply the acquired knowledge and analytical approaches to problem-solving in both contractual and non-contractual commercial relationships relevant within the European Union and the broader global context, and to utilize them in practice. Furthermore, they will develop their argumentation, analytical, and presentation skills, as well as the ability to apply theoretical knowledge to practical situations.

Schedule of subject:

The course focuses on current issues and selected aspects of commercial law with an emphasis on the European and global dimensions. The instruction consists of online lectures followed by an in-person component conducted over five days. The specific content of the study program unit is determined individually.
